

## **TERMS & CONDITIONS OF ENROLMENT**

References in these Terms and Conditions to 'Inspire', 'we', 'our' and 'us' means Inspire Operations Pty Limited (ABN 64 601 894 062) trading as Inspire Program Australia and its related entities.

References to 'l', 'my' and 'you' are to the parent/s/guardian/s who completed and signed the enrolment form for the services. By using any of Inspire's services, you agree to be bound to our Terms & Conditions.

- 1. I state that all information provided to Inspire is accurate and complete. It is also my responsibility to <u>advise of any changes to the information</u> including details of health or medical condition and/or medication for my child/ren.
- Inspire staff reserves the right, after all reasonable attempts have been made to contact the parents/guardians and authorised nominees stated on the enrolment form, to seek <u>medical treatment</u> from a registered medical practitioner, hospital or ambulance service; and transportation of the child by an ambulance service, should the need arise, and I agree to pay such costs as may be incurred.
- 3. Inspire staff may administer first aid to my child/ren if required. This may include (but not limited to) use of disinfectant, band aids, bandages, soothing creams and ice packs.
- 4. I will ensure that any prescribed medication for my child, such as Ventolin or an EpiPen, is provided to be kept at the centre. I will replace this medication when notified by centre staff that it is approaching its expiry date.
- 5. My child/ren can use the provided sunscreen whilst at an Inspire centre. If not, my child/ren will carry and use their own sunscreen.
- 6. In accordance with our collection of children policy, Inspire has no right to refuse access to parents of the child/ren.
- 7. My child/ren must be collected before the centre's closing time. I must contact Inspire head office on 1300 665 275 if I am expected to arrive after the centre's closing time. A late pick up fee may be applied. If my child/ren have not been collected within half an hour of the centre closing and parents/guardian have made no contact with Inspire, we have the right to take your child/ren to the closest police station.
- 8. The late pick up fee is \$10.00 per 5 minutes for any time after the centre's closing time. This fee is billed in your next fee cycle.
- Daily attendance <u>fees are billed fortnightly, payable 2 weeks in advance via direct debit</u>. Inspire reserves the right to revise our fees periodically, with any changes taking effect after providing you with a minimum of 2 weeks notice.
- 10. I agree to Inspire's session hours of 7:00am till 6:00pm. I agree that I will be charged for the full session of care even if my child/ren does not attend the whole session.
- 11. It is my responsibility to comply with the requirement of the child care subsidy, and if I fail to do so, I will be responsible for paying full fees.
- 12. Once your child's enrolment is confirmed, **bookings cannot be cancelled**, and the daily fees for the booked days is non-refundable.
- 13. Families only attending our School Holiday Fun program will be charged an annual administration fee of \$30.
- If my account is not paid in full upon my child/ren leaving the Centre, Inspire reserves the right to commence a <u>debt recovery</u> procedure. I agree to bear all costs and fees associated with this process.
- 15. Subject to current law, I acknowledge and agree that *Inspire* nor its staff will not accept responsibility for <u>personal injury or liability for the loss or damage of</u> <u>personal effects</u> of my child/ren sustained whilst attending an Inspire centre, or at a venue where Inspire is holding an event that my child/ren attends.
- 16. Inspire staff may take appropriate <u>photographs/video</u> of my child/ren, as an individual or in a group while attending an Inspire centre or at a venue where Inspire is holding an event that my child/ren attends. Photographs/video may be used for (but not limited to) the Inspire educational materials, reflection journal/poster, school communications and newsletters, and various marketing brochures. We will not identify your child/ren's name (or other personal details) at any time. I will contact Inspire's head office on 1300 665 275 or via email at info@inspireprogram.com.au if I do not authorise Inspire staff to take photographs/videos of my child/ren.
- 17. Inspire has the <u>rights to vary these Terms & Conditions</u> periodically and will notify parents/guardians accordingly. Amendments will take effect from the date notified (unless specified otherwise). If you do not agree to any material amendments as notified, you may cancel your child/ren's enrolment, effective from the date that you notify us.
