

Inspire Taekwondo

Liability Waiver and Acknowledgment of Risk



- I, the parent or guardian of the student/s name below, hereby state that I consent to my child/ren attending and/or participating in Inspire Taekwondo classes.
- I understand and agree that in undertaking training at Inspire Taekwondo high performance classes there is a possibility of serious physical injury and even fatality to my child/ren. I acknowledge that the injury may be a result of strenuous exercise or high impact or repetitive movement and that my child/ren may suffer harmful physical contact as a consequence of technique delivery, evasion or application of counter techniques by my child/ren or another person.
- I voluntarily assume all risks and responsibility for any such injury, accident or death, which might occur to my child/ren during or after each Inspire Taekwondo classes, as a result of their participation or attendance at the venue and surrounds where training/ activities may occur.
- I understand if my child/ren is unfit or unwell, they will not be attending Inspire Taekwondo. If they participate at Inspire Taekwondo I acknowledge that they are fit and in good physical condition and fully able to participate in the classes.
- I hereby release, waive and discharge Inspire Taekwondo and all of its staff and students from any and all liability claims, demands or causes of action from any damage, loss, injury or death to my child/ren or their property which may arise out of or in connection with participation or attendance in any classes.
- I (for myself, my heirs, executors and administrators) waive release and discharge Inspire Taekwondo and its representatives from all claims or cause of action I may have (including for negligence) arising from any injury, loss or damage of any kind my child/ren may suffer including personal injury, illness or death and/or loss or damage to any property arising either directly or indirectly out of their participation or attendance at Inspire Taekwondo.
- If any part of this Liability Waiver and Acknowledgment of Risk shall be deemed by a Court of competent jurisdiction to be invalid, then the remainder of this Liability Waiver and Acknowledgment of Risk shall remain in full force and effect.
- I acknowledge that my child/ren are aware of their physical limitations and they will not exceed them.
- I give permission for Inspire Taekwondo to use photographs and video of my child/ren for marketing and publicity purposes.

I have read, understood and agree to all of the above terms.
